Consultation on the Blaby Local Plan Delivery DPD Post Hearing Main Modifications

Blaby District Council would like to invite representations on the Local Plan Delivery DPD Post Hearing Main Modifications Consultation.

The Local Plan was submitted to the Secretary of State on 23 March 2018. Hearing sessions took place between 31 July – 2 August and 14 – 15 August 2018. As a result of the hearing sessions a number of Main Modifications have been prepared to make the Delivery DPD sound.

The Main Modifications are now subject to public consultation. The consultation runs from **14 September until 4.45pm on 26 October 2018**.
